

**RELEASE AND AUTHORIZATION**

(DO NOT SIGN RELEASE UNTIL YOU HAVE READ IT)

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the undersigned, hereby irrevocably permit, authorize, grant and license to the National Association of Broadcasters Leadership Foundation (hereinafter "Producer), Producer's successors, affiliates, licensees and assigns, and the employees, officers, directors and agents of each of them (collectively, "Authorized Persons"), the rights to record, depict, portray, display, exhibit, publicly perform, distribute, create derivative works of, exploit, modify, alter, edit, reproduce, transmit, broadcast, license and/or otherwise use in any manner Producer desires, and to grant to others the same rights to use in any manner desired, my name, actual or simulated likeness, image, appearance, photograph, voice, sound effects, actions and all artistic, literary, dramatic, musical and other materials created by or on behalf of Producer (including materials created by me) that incorporate any of the foregoing (collectively, "Materials") in and in connection with the production, exhibition, reproduction, public performance, transmission, broadcast, distribution, advertising, promotion and merchandising of the Program (defined below) . Without limitation of the foregoing, I hereby irrevocably consent to the use of my name, likeness, image, appearance, voice persona or other sound effects, actions, any Materials, and any reproduction thereof, alone or together with any content from any motion picture, television or other productions, in and in connection with the production, exhibition, reproduction, public performance, transmission, broadcast, distribution, advertising, promotion and merchandising of the "Celebration of Service to America Awards" and/or any other program (collectively, "Program"), in all languages, formats, platforms and media, now known and hereafter devised, in any manner, throughout the universe in perpetuity. All Materials, together with the results and proceeds of your participation in connection with the Program are specially commissioned by Producer as a work made for hire. Accordingly, Producer is the author and owner of all right, title and interest in and to the Materials, including, but not limited to, all copyrights in the Materials (and all renewals and extensions thereof), with the right to use and change the Materials in any manner that Producer may determine. If any of the Materials is determined not to be a work made for hire, I hereby assign to Producer in perpetuity all right, title and interest in and to the Materials, including, but not limited to, all copyrights in the Materials (and all renewals and extensions thereof). With respect to such Materials, I hereby grant Producer an exclusive gratis license to any third-party content included or appearing therein and agree that I shall be responsible for securing any and all third-party rights and/or permissions necessary for any individual(s), location(s), content and/or material(s) featured in and in connection with my participation in the Program. I understand and agree that the Producer reserves the right to modify, reschedule, postpone, cancel and/or not utilize my segment at any time prior to the date of taping and/or airing of the Program, for any or no reason. I agree that I shall be entitled to no additional consideration as a result of the exercise of the rights granted herein. To the fullest extent permitted by applicable law, I hereby irrevocably waive and release Producer and all others, including, but not limited to, sponsors and advertisers connected with the Program, as well as the Authorized Persons, and each of their respective officers, directors, shareholders, employees, agents, representatives, successors, licensees and assigns, from any and all legal and equitable claims, liabilities, demands, actions, suits, damages and expenses (whether known or unknown) that I have or may have, directly or indirectly resulting from or related to my participation in the Program and/or from the exercise of any of the rights granted to Producer and the Authorized Persons above. I further irrevocably waive any right to seek or obtain injunctive or other equitable relief with respect to any of the rights granted to Producer and the Authorized Persons hereunder, as well as any right of inspection or approval of the proceeds of any Materials or Program or the uses to which such proceeds may be put and the right to assert any claims relating thereto. Producer may freely assign this agreement and its rights hereunder to any person or entity (including, without limitation, the Authorized Persons). For purposes of this Release, a facsimile or other electronic version of a party's signature, such as a .pdf printed by a receiving facsimile or printer will be deemed an original signature. This Release will be deemed drafted jointly by the parties and no ambiguity is to be construed against one party over the other.

I understand and agree that this is the complete and binding agreement between me and Producer, superseding all prior understandings and communications with respect to this subject matter. This agreement shall be exclusively governed by and construed in accordance with the laws of the District of Columbia applicable to agreements entered into and wholly performed therein.

I warrant that I am at least eighteen (18) years of age (or, if not, that my parent or legal guardian has agreed to the foregoing and signed below) and that I have the full, complete and unrestricted right and authority to enter into this release. I understand that Producer will proceed in reliance hereon.
